Bill Roberts motioned that SARA supports that City Planning meet and consult with affected Ratepayers Groups prior to final approval of the Mid-Rise Guidelines. The motion was seconded by Veronica Wynne and carried.

- c. 34 Southport C of A report and Site Plan involvement for SKNC & SARA Veronica, Nick, Sybil, Ian, Councillor Doucette (10-15 minutes). Three motions from Bill: 1. Approve Veronica Wynne give water table documentation to CORRONA that they can submit to Planning. 2. Nick and Veronica communicate additional Geotech information to the Chief Building official for the project. 3. That SARG request that they be involved as a party in the Site Plan approval process. Veronica will write the letters for John Meijer's signature. Keith, Ian, Brain seconded each motion respectively. All motions were carried.
- d. 2265 Bloor Site Plan approval Community Involvement Anthony Hommik is receiving comments for review. Once review is done, a meeting will be held.
- e. YIMBY Event? Ian McIssac reported that he and Bill Roberts attended the meeting at Ryerson University. Ian identified a number of groups that may be of interest to SARA/SARG from a number of different aspects. He described these groups and will summarize them in an email for review. We need some items to "jazz up" the table.
- f. South Kingsway/Mossom Intersection Report Sydney Reimer reported the findings of the report, noting the problems between the lights at Jane and South Kingsway. There are opportunities for light timings and prioritization between east and west depending on time. Also the left turn lanes may be expanded if the diving lanes are narrowed. The entrance to Mossom and/or the configuration of Mossom could be changed as there are problems with cars, bicycles and pedestrians. Bill motioned that the Sub-Committee provide their documentation to Transportation and ask Transportation to come to the area to investigate the problems on site at the appropriate time. The motion was seconded by Ian McIssac and carried. Bill Roberts motioned that Sydney consult adjacent Ratepayers groups the motion was seconded by Kate Lawson and carried.
