# 1. CALL TO ORDER AND DECLARATION OF CONFLICTS OF INTEREST:

The meeting was called to order by Nick Singh at 7:38 pm.

### 2. AGENDA AMENDMENTS & APPROVAL:

n) Local Matters - Decision Making Being Transferred to Planning and Growth: Bill Roberts attended the meeting, and explained the proposed process to decide if planning matters will be decided by the Planning and Growth Management Committee. SARA's letter was filed. Local groups essentially want local matters to remain local with the local Councillor involved in the decision. Avenue Studies and Secondary Planning should remain local unless they cross a community boundary. As well, CORRA has asked for transparency in completing the application planning process. That is, while the complete application is being assembled, both the ward councillor, and possibly the community, via the ward councillor, is involved. The public should be guaranteed that at a minimum, the ward councillor and possibly the public have access to, possibly at a reasonable cost, reports used in the application.

o) Capital Budget – Homeowners Subsidizing New Development: David Fleming will send the Executive an email from FoNTRA that describes the issue. Essentially, 10% of infrastructure costs are paid by the development industry, with the rest being picked up by taxpayers. It was also discussed that the planning department is understaffed. Sybil Wilkinson motioned that she write a letter to ???????? that SARA is concerned, that the Planning Department is understaffed, and the low proportion of development charges as they relate to the cost of new development.
