CORRA – ZONING BY-LAW HARMONIZATION

You may be aware that the repeal of the harmonized Zoning By-law 1156-2010 was approved by City Council at its meeting of May 17/18. Council has now asked staff to engage in consultations with the appellants and report back to P&GM Oct 6 for recommendations to Council at its meeting on Nov 8, for possible enactment of changes next Feb, 2012. Staff is not authorized to enlarge the scope of by-law changes, and SARA will be a participant in the process.

WEST END COMMUNITY GROUPS / CORRA REVITALIZATION

COMMITTEE OF ADJUSTMENT/ PLANNING MATTERS - SARA

continues to monitor all minor variance applications in Swansea which go before the Committee of Adjustment. This is to ensure their appropriateness and desirability for the neighbourhood and community. Below are recent applications of interest:

155 Morningside – This application was unanimously refused by Committee of Adjustment back in April and the OMB appeal has been postponed pending further negotiations.

70 Lavinia, Fourteen variances were approved by the Committee of Adjustment on Feb 3 for an application to construct a second story addition, front and rear additions and a second suite. This was appealed at OMB by adjacent neighbours, with SARA supporting the neighbours' appeal. The OMB decision came out Sep 1 authorizing all but two of the nine (after repeal of harmonized by-laws) requested variances but added conditions in regard to the north side yard setbacks and requiring new windows facing

adjacent properties to not open to allow views into adjacent windows and that they be frosted. The project will have to be redesigned to meet the conditions.

45 Morningside, The Committee of Adjustment hearing on 3 March approved the severance and construction plans for two new homes, despite the community and SARA's opposition. SARA is unaware that any appeal was launched.

2 Wendigo Way, This proposal for a new two-storey detached dwelling was to be heard Sep 8 at Committee of Adjustment on four variance requests pertaining to GFA and setbacks. However SARA learned that the hearing was adjourned at the request of Forestry for concerns about several mature trees on the property.

263 Ellis Ave – This application for a third floor addition plus rear deck involved seven variances (including the new by-law variances since repealed). It was heard for a second time at CoA on May 12 and was authorized after some roof slope alterations were made.

15 Runnymede Road, An application to construct an additional dwelling unit in the existing building, resulting in a Triplex, was denied by CoA on Feb 3, after failing to meet the tests of the planning act. The decision was appealed to the OMB by the applicant, and was denied by oral decision of June 28, after the City gave planning evidence, stating that it met none of the four tests of the planning act, where it need fail only one.

42 Morningside, This application went back to Committee of Adjustment on Sep 8 for a missed side yard variance of 0.18m.

YIMBY - SARA we be attending the 5th Annual YIMBY (Yes in My Back Yard) Festival — YIMBY AT FIVE on October 22, 2011 at the Gladstone Hotel. This festival provides a social space for people and groups involved in grassroots, locally-driven community development to gather, exchange ideas and strategies to effect change, and imagine their future city.

SOUTHPORT PLAZA

SARA is fundraising for a retail marketing study to examine potential commercial opportunities at the Southport Plaza site. We plan to meet with the developer to discuss further funding and mutual benefits from any study undertaken.

SOUTH KINGSWAY / QUEENSWAY RAMPS

SARA wants improved sightlines at the stop sign turning west off South Kingsway onto the Queensway. We have raised the issue with city staff and Ward 13 Councillor Doucette.

TTC SOUTHKINGSWAY STOP

SARA would like to see the stairwell from South Kingsway down to the Queensway restored to operation, however we have learned that the City is not looking at the staircase as priority right now.

BLOOR STREET / UKRAINIAN FESTIVAL— there will be a road closure of Bloor Street for the 15th annual Bloor West Village Toronto Ukrainian Festival to be held September 16, 17 and 18, 2011.
