2265 BLOOR (AT DURIE) DEVELOPMENT PROPOSAL

A new condo has been proposed for 2265 Bloor Street West through to 2279 Bloor Street West. This stretch of property is on the south side of Bloor starting at Durie Street (across from Queen's Pasta) and stretching to the flower shop just before the Bloor Street Meat Market. It calls for an 8 story mixed use building comprised of 83 residential dwelling units as well as 1200m² of non-residential office and retail.

The developer has appealed to the OMB for permission to proceed, and SARA was involved in the meeting of the Etobicoke-York community council where the City motioned to send a City lawyer and planner to oppose the development at the OMB, as well as to ask for adjournment until a Bloor West Village area study can be completed.

Nevertheless, it appears the community must be prepared to defend itself against this proposal and so SARA is working together with the other local resident associations, under the Save Our Village banner (www.saveourvillage.ca) to raise funds for an OMB fight. Please consider donating to support this effort.

2217 BLOOR (AT HARCROFT) DEVELOPMENT PROPOSAL

A preliminary community consultation was held Aug 20 at Swansea Town Hall, by the developer, Main and Main, of the site at 2217 Bloor. SARA was in attendance, and the developer sought input on its plans for ground level retail, with residential condos above. No concrete plans are yet available.

1926 LAKESHORE (4 POINTS SHERATON) DEVELOPMENT

There was a mediation held during the summer in which the South Swansea Neighbourhood Committee, the developer Carterra, and the City participated and reached a settlement which was approved by the OMB. SARA was involved, and supported the local community's interests. The proposal is for two 35 storey towers above a 5 floor podium and a minimum 315 sq m of commercial/retail at grade, and a reduction in density and below grade parking. The applicant originally sought two towers of 42 and 48 storeys. The community benefits include parkland improvements and section 37 funds.

ANNUAL GENERAL MEETING – The 2014 Annual General Meeting was held on Wednesday, June 4 with **Supt. Heinz Kuck**, 11 Division Toronto Police, as the speaker. He spoke on community engagement, graffiti eradication, and his fundraising efforts, among other topics.

CORRA – CORRA is involved at the moment with matters including the Development Permit System, the Island Airport, the Consolidated Zoning bylaw, Official Plan review, and more.

RENNIE PARK GARAGE SALE – "Treats and Treasures" was held indoors at Swansea public school on Apr 26th.

SWANSEA LEGION – was sold to a private individual for their own use. Currently, the owner is envisioning a private residential unit on the main and upper floors, and a yoga studio in the lower floor, contingent upon zoning changes which are being sought.

HERITAGE CONSERVATION DESIGNATION – SARA worked with other local ratepayer groups and the city councilor on a Heritage designation which is awaiting review.

ZONING BY-LAW HARMONIZATION / OFFICIAL PLAN REVIEW SARA is appealing the City's Zoning By-Law harmonization, and monitoring the Official Plan review.

COMMITTEE OF ADJUSTMENT/ PLANNING MATTERS – SARA continues to monitor all minor variance applications in Swansea which go before the Committee of Adjustment. This is to ensure their appropriateness and desirability for the neighbourhood and community. Below are some recent applications of interest:

90 South Kingsway— The application was approved at its second Committee of Adjustment hearing, with modification of the front yard parking which was objected to by SARA.

52 South Kingsway – is now under construction.

70 Lavinia - this property has been sold to a new owner

304 South Kingsway - This is the building at the top of South Kingsway at Mossom Road. There is concern that the building has been turned into a rooming house. City Planning has not been effective at inspecting the building. SARA is pursuing the matter.

83 Morningside Ave – this is going before Committee of Adjustment on Oct 2. SARA is looking into the large number of variances requested.

SOUTHPORT PLAZA

Nick Singh agreed to chair SKNC, who plan to meet in October. There remain concerns over i) retail and ii) geotechnical studies. SKNC is looking to fundraise \$500 for a geotechnical peer review. SARA also has some concern over lack of information on site plan progress
